## 6-3 Authorization for Executive Director to enter into an Agreement with Schaefer Engineers for the Westminster Woods Water Conservation and Storage Project, funded by Department of Fish and Wildlife Grant Agreement P1430403.

Schaefer Engineering, Inc., is contracted for installation of water lines, a new irrigation system, and associated water distribution components, as well as grading, soil amendment, turf replacement, and demolition of the old irrigation system at the Westminster Woods site. Work will begin November 2015. The contract amount is \$57,000 and the Agreement expires on May 31, 2016.
