- 6-2 Authorization of Executive Director to enter an Agreement with Prunuske Chatham Inc. for services required through the California State Coastal Conservancy (SCC) grant agreement 16-006 for a contract amount of no more than \$127,068.00.

The goal of this project is develop two 30% designs for off-channel high flow refugia habitat for salmonids on the Iron Horse Vineyards.

6-3 Resolution 2017-01 of the Gold Ridge Resource Conservation District authorizing submittal of application for the Farm and Ranch Solid Waste Cleanup and Abatement Program for an amount of \$11,511.

The goal of this project is to clean up an abandoned illegal marijuana grow discovered on a Bodega ranch.

6-4 Review of bids, selection of contractor and approval for Executive Director to enter into contract not to exceed \$50,000 with selected contractor at bid amount for Dei Dairy Stormwater Management Project, funded by SWRCB 12-401-251.

The project was identified in a Comprehensive Nutrient Management Plan (CNMP) that was prepared by GHD, Inc. in April 2016. The project involves the installation of gutters, gutter hardware, downspouts, and associated components related to a stormwater management project. There are six buildings designated for work and the buildings require some minor structural reinforcement to attach the gutters in a safe and functional manner. The producer has applied for USDA NRCS EQIP funding to complete the underground outlet portion of the project.

6-5 Authorization for Executive Director to enter an Agreement with Mendocino County RCD (MCRCD) for services required through the California Department of Food and Agriculture (CDFA Grant Agreement No. SCB16073), to implement a project entitled, "Climate-Beneficial Vineyard Management Practices for the North Coast Area." Gold Ridge RCD will be providing services to the MCRCD-SCBG-2017-03 to assist landowners to develop "LandSmart Vineyard Carbon Farm Plans;" conduct Soil Health Assessments, soil sampling, demonstration trials, and provide Project outreach and education activities for a contract amount of no more than \$64,215.00.
